ORDER CANCELING CERTIFICATE AND ACCOMPANYING TARIFF

Issue Date: November 24, 2010

Effective Date: December 4, 2010

On November 1, 2010, the Staff of the Missouri Public Service Commission filed a motion requesting Telecommunications Service Center, Inc. ("Telecommunications Service Center") certificate of service authority and accompanying tariff to provide interexchange telecommunication services in the State of Missouri be cancelled.

In File Number TA-94-386, the Commission granted Telecommunications Service Center a certificate of service authority to provide interexchange telecommunication service in the State of Missouri. The Company's tariff, P.S.C. MO No. 1, was also approved.

Staff states in its motion that according to the Missouri Secretary of State's Office, Telecommunications Service Center is administratively dissolved. Because the company cannot legally operate in the State of Missouri, Staff recommends that the Commission cancel the company's certificate of service authority to provide interexchange telecommunications services, and the company's accompanying tariff.

On November 3, 2010, the Commission issued an Order Directing Notice allowing any parties to file an objection or request a hearing to do so no later than November 15, 2010. No objections or requests for a hearing were filed.

The Commission has the authority to cancel a certificate and tariff pursuant to Section 392.410.5, RSMo, which states, in part, “[a]ny certificate or service authority may be altered or modified by the commission after notice and hearing, upon its own motion or upon application of the person or company affected.”

Based on Staff’s motion, the Commission finds that the certificate of service authority and accompanying tariff granted to Telecommunications Service Center, Inc., shall be canceled.

IT IS ORDERED THAT:

1. The certificate of authority to provide interexchange telecommunications services granted to Telecommunications Service Center, Inc., in File Number TA-94-386, is canceled.
2. Telecommunications Service Center, Inc.’s tariff, P.S.C. MO No. 1, is canceled.
3. This order shall become effective on December 4, 2010.

4. This case may be closed on December 5, 2010.
