PUBLIC SERVICE COMMISSION

The Secretary of the Commission shall send notice of this Order the members of the General Assembly representing the area served by Virginia Properties, Inc. and to the publisher of each newspaper located in the service area of the Company as listed in the Newspaper Directory of the current Official Manual of the State of Missouri. The Secretary of the Commission shall serve a copy of this Order upon the presiding Commissioner of the County Commission of Jefferson County.

The statutory trustees for Virginia Properties, Inc., should send notice of the proposed sale and transfer to the affected customers by mail.

It is, therefore,

ORDERED: 1. That any interested person or entity shall file its application to intervene or motion to schedule a hearing in this matter on or before December 5, 1985.

ORDERED: 2. That the following notice shall be sent to the Virginia Properties, Inc.'s affected customers on or before November 25, 1985:

By application, the statutory trustees for Virginia Properties, Inc., have requested the Missouri Public Service Commission to enter an order authorizing them to sell and transfer its franchise, works or system necessary and useful in the rendition of sewer treatment service to M.P.B. Inc.

Persons or entities desiring to formally participate in the case must file an application to intervene on or before December 5, 1985, with the Secretary of the Public Service Commission, P.O. Box 360, Jefferson City, Missouri 65102 and send a copy to the Company's attorney, John Howald, One Thurman Court, Hillsboro, Missouri 63050 and M.P.B. Inc.'s attorney, Cars L. Detring, West First & South Jefferson, Farmington, Missouri 63640.
