Further, the Commission notifies the Applicant that the application may not conform to the Commission's rules concerning applications in general or to those specifically

concerning the authority Applicant seeks. Applicant should review the Commission's rules<sup>1</sup> for compliance. Applicant must furnish the information required under the Commission's rules prior to the Commission granting the requested relief.

1. The Commission's Data Center shall send a copy of this order to the County Commission of St. Clair County, Missouri.

2. The Commission's Information Officer shall make this Order and Notice available to the members of the General Assembly who represent constituents in St. Clair County, Missouri and to the newspapers and other media which serve Applicants' service areas.
