### **ORDER DIRECTING FILING**

On August 30, 2005, Southwestern Bell Telephone, L.P., d/b/a SBC Missouri, filed, in Case No. TO-2006-0093, a request for competitive classification of certain services in numerous exchanges within its service territory. SBC Missouri's application contained a request that certain exchanges be addressed under the 30-day track found in Section 392.245.5, RSMo (2005), and that other exchanges be addressed under the statute's 60-day procedure. By notice issued September 2, 2005, the Commission informed the parties in Case No. TO-2006-0093 that the portions of the petition regarding the 60-day track would be addressed in a new case, Case No. TO-2006-0102.

On September 26, 2005, the Commission issued its Report and Order in TO-2006-0093. Among other things, that order directed that some exchanges would be transferred to this case, TO-2006-0102, for consideration. Consequently, the exchanges that will be addressed in this case are as follows:

**Business Services Exchanges:** Archie, Ash Grove, Billings, Boonville, Carthage, Cedar Hill, Chaffee, Chillicothe, De Soto, Dexter, Excelsior Springs, Farley, Gray Summit, Hannibal, Hillsboro, Kennett, Kirksville, Linn, Marionville, Marshall, Mexico, Moberly, Montgomery City,

Neosho, Portage Des Sioux, Richmond, St. Clair, Union, Ware, and Webb City.

Residential Services Exchanges: Antonia, Archie, Ash Gove, Billings, Bonne Terre, Boonville, Camdenton, Cape Girardeau, Carthage, Cedar Hill, Chillicothe, Clever, De Soto, Dexter, Eldon, Excelsior Springs, Farley, Festus-Crystal City, Flat River, Fulton, Grain Valley, Gravois Mill, Gray Summit, Greenwood, Hannibal, Herculaneum-Pevely, High Ridge, Hillsboro, Imperial, Jackson, Joplin, Kennett, Kirksville, Lake Ozark-Osage Beach, Marionville, Marshall, Maxville, Mexico, Moberly, Neosho, Poplar Bluff, Portage Des Sioux, Richmond, San Antonio, Sedalia, Sikeston, St. Clair, Union, Walnut Grove, Ware, and Webb City.

In reviewing SBC Missouri's application, the Commission determines that it requires additional information. The Commission will therefore direct SBC Missouri to expeditiously file certain supplemental information. First, SBC Missouri shall file updated versions of Exhibits B-1 and B-2, and updated maps, like Exhibits B-3 and B-4, that contain the additional exchanges transferred from Case No. TO-2006-0093. These updated exhibits shall be designated as Revised Exhibit B-1, Revised Exhibit B-2, Revised Exhibit B-3, and Revised Exhibit B-4. Second, SBC Missouri should provide the names of each of the competitors that SBC Missouri refers to, by number only, in Revised Exhibit B-1 and Revised Exhibit B-2. SBC Missouri shall also file supplemental information, like what is found in Exhibits A-1 and A-2, showing SBC Missouri's sources of data for each of the competitors.

**IT IS THEREFORE ORDERED:**

1. That no later than 12:00 p.m. on October 4, 2005, Southwestern Bell Telephone, L.P., d/b/a SBC Missouri, shall file supplemental pleadings as directed above.

2. That this order shall become effective on September 30, 2005.
