MOTION FOR EXTENSION OF TIME TO FILE STAFF’S BRIEF

Comes now the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and for its *Motion for Extension of Time* states the following:

1. On January 19, 2010, Roman Dzhurinskiy (“Complainant”) filed a Complaint against Missouri-American Water Company (“MAWC” or “Company”) with the Missouri Public Service Commission (“Commission”).
2. On February 26, 2010, MAWC filed its Answer with the Commission.
3. On November 15, 2010, the Commission conducted a hearing in this matter.
4. On December 3, 2010, the Commission issued a Briefing Schedule which provides that the Staff shall file its brief no later than February 2, 2010.
5. Due to the inclement weather that occurred on February 1 – 2, 2011 and technical difficulties that resulted, Staff requests an extension until February 4, 2010 in which to file its brief in this matter.
6. Staff has communicated this request with counsel for MAWC who has no objection to this request for extension.

7. Staff emailed and spoke to Complainant, who does not object to this request but seeks an extension of two weeks beyond the current date in which to file his reply brief, which would be March 7, 2011.

WHEREFORE, Staff respectfully requests the Commission grant a two (2) day extension, until February 4, 2011, for Staff to file its brief. Staff further requests that the Commission consider Complainant's request to have an additional two weeks, until March 7, 2011 to reply to any briefs filed by MAWC or Staff in this matter.
