STAFF COMPLIANCE TARIFF RECOMMENDATION

COMES NOW the Staff of the Missouri Public Service Commission (Staff), by and through counsel, and hereby submits this *Staff Compliance Tariff Recommendation*.

1. On April 7, 2021, the Commission issued its *Order Approving Stipulation and Agreement* (*Order*) in the above-styled case. The *Order* rejected the tariff sheets filed by Missouri-American Water Company ("MAWC") on June 30, 2020, and authorized MAWC to file tariff sheets sufficient to recover revenues as determined by the Commission in its *Order*.

2. On April 28, 2021, MAWC filed its compliance tariff sheets consistent with the Commission's April 7, 2021, *Order* bearing an effective date of May 28, 2021, and given tariff tracking numbers YW-2021-0189 and YS-2021-0190. The next day, April 29, 2021, the Commission issued its *Order Directing Filing of Staff Recommendation* ordering Staff, no later than May 10, 2021, to file a recommendation regarding the compliance tariffs filed by MAWC.

3. After review, Staff concludes that the filings comply with the Commission's April 7, 2021, *Order Approving Stipulation and Agreement*. Thus, Staff recommends approval of:
