On March 3, 2023, MAWC and other parties filed a Stipulation and Agreement (Stipulation). The Stipulation resolves most of the issues. However, as enumerated in the parties’ List of Issues filed on February 16, 2023, Issues 3a (Affiliate Transactions), 13 (Class Cost of Service), and 14 (Rate Design) (the “Remaining Issues”), are not resolved by the Stipulation.

The Commission is available to hear the Remaining Issues on March 9-10, 2023. The Commission will require the parties to respond expeditiously whether they wish to proceed to hearing on the Remaining Issues on March 9-10. In the alternative, the parties may state whether they wish to proceed to hearing at a later date, or whether a hearing will not be needed due to the parties’ resolving the Remaining Issues through another stipulation.

THE COMMISSION ORDERS THAT:

1. The parties shall respond as ordered above no later than 2:00 p.m., March 6, 2023.

2. This order shall be effective when issued.
