ORDER GRANTING STAFF’S MOTION TO ADD A HEARING DAY

On July 26, 2023,¹ the Staff of the Commission (Staff) filed its *Motion for Additional Hearing Days and Motion for Expedited Consideration* (Motion).

The Motion asks for the Commission to extend the current hearing schedule by adding Monday, August 14 to the schedule. The Commission previously had a conflict on that date that has since been resolved.

The Commission finds the request reasonable and will grant it. If any party has a scheduling conflict for the added date, they should contact the regulatory law judge.
