On July 12, 2023,<sup>1</sup> the Commission issued its order (July 12 Order) regarding two data requests (DRs).

On July 25, Staff filed its *Motion for an Order Requiring Immediate Compliance with the Commission's Discovery Order and Motion for Expedited Consideration* (Motion).

The Commission notes the start of the evidentiary hearing is approximately two weeks away, and thus will order expedited responses. The Commission will also set a prehearing conference for the parties to discuss Staff's Motion and the upcoming evidentiary hearing. This prehearing conference will occur either July 28 or July 31.

**THE COMMISSION ORDERS THAT:**

1. Confluence Rivers shall file a response to Staff's Motion no later than July 31, 2023.
2. No other party is required to respond to Staff's Motion, but if they wish to do so, responses shall be filed no later than July 31, 2023.
