ORDER REGARDING INTERVENTION

Issue Date: November 9, 2022

Effective Date: November 9, 2022

On July 6, 2022, the Commission issued an Order Directing Notice and Establishing Time to Intervene. That order set a deadline of July 26, 2022 for interested parties to request intervention.

On October 10, 2022, Consumers' Council of Missouri (CCM) filed its Late-Filed Application to Intervene. CCM stated that due cause exists to permit its late-filed application because it had only just recently become aware of the case.

On October 20, 2022, Missouri-American Water Company (MAWC) objected. MAWC stated that CCM was a party to MAWC's prior rate case, and that the Commission's July 6, 2022 order instructed the Commission's Data Center to notify all parties in MAWC's prior rate case of this case. Thus, CCM received actual notice of the rate case, and CCM, therefore, does not have good cause for its late-filed application.

Commission Rule 20 CSR 4240-2.075(10) allows the Commission to grant untimely intervention requests for good cause shown. The Commission finds CCM has shown good cause to intervene. CCM's intervention will not prejudice any party, as direct

non-company testimony is not due until November 22, 2022. Thus, the Commission will grant CCM's application.

THE COMMISSION ORDERS THAT:

1. CCM's late-filed application to intervene is granted.
2. This order shall be effective when issued.
