## **MOTION FOR EXPEDITED TREATMENT**

Comes now WST, Inc. ("WST"), through its legal counsel, and requests this Commission to establish an expedited schedule for the consideration and entry of an order in the accompanying Application for a Variance from Kansas City Power & Light Company's General Rules and Regulations Requiring Individual Metering, and in support thereof states as follows:

- 1. WST respectfully requests that the Commission act upon the accompanying Application for Variance by October 19, 2005.
- 2. The project for which a variance is being sought is in its final stages of construction, in anticipation of having units ready for closings on October 19, 2005. If the variance is not granted by then, WST and the buyers will incur irreparable harm and damage as a result of the failed closing dates.
- 3. The variance request was filed as soon as possible, after it was determined that it was needed. It was not until August 16, 2005 that Kansas City Power & Light Company ("KCPL") sent written notification to WST that KCPL would be requiring individual metering to each condominium unit. WST, through its legal counsel, responded to KCPL on August 30,

2005. KCPL replied to that letter on September 15, 2005, advising WST that a variance to KCPL's tariffs would be required.

WHEREFORE, WST, INC. respectfully requests this Commission to make and enter its Order as stated in the accompanying Application for Variance by October 19, 2005, or as soon as the Commission is able.
