**SUGGESTED LANGUAGE OF KANSAS CITY POWER & LIGHT COMPANY
FOR NOTICE TO WALLSTREET TOWER CONDOMINIUM UNIT OWNERS**

Pursuant to the order issued by the Public Service Commission of the State of Missouri ("Commission") on October 13, 2005, in the above-captioned proceeding, Kansas City Power & Light Company ("KCPL") hereby submits its suggested language for the notice to be given to purchasers of condominium units at the Wallstreet Tower condominium project located at 1101 Walnut, Kansas City, Missouri ("Wallstreet Tower").

1. On October 13, 2005, the Commission issued an order directing the parties to this proceeding to "file written suggestions regarding the language of an appropriate notice to be given to purchasers of condominium units no later than 1:00 p.m. on October 17, 2005."
2. In accordance with the Commission's order, KCPL proposes the following language for the notice to Wallstreet Tower condominium unit owners concerning the provision of their electric service:

**NOTICE TO CONDOMINIUM OWNERS CONCERNING
THE PROVISION OF ELECTRIC SERVICE AT WALLSTREET TOWER**

As a unit owner in the Wallstreet Tower condominium project, you will be purchasing electric service from the WallStreet Tower Condominium Association, Inc. ("Association") You are not a customer of Kansas City Power & Light Company ("KCPL"). The consumer protection provisions of KCPL's tariff on file with the Public Service Commission of the State of Missouri do not apply to the Association's provision of your electric service. The terms and conditions of your electric service are as set forth in your contractual agreement with the Association. In the event of an

interruption in electric service, please contact the Association who will, if necessary, contact KCPL.

3. KCPL respectfully offers this suggested language for the notice to the owners of condominium units at Wallstreet Tower, as requested by the Commission in its October 13, 2005 order.
