3. On September 3, 2021, MAWC filed its petition to establish water and sewer infrastructure rate adjustments (WSIRAs) under newly enacted Sections 393.1500-1509, RSMo. MAWC also requested that the Commission approve its proposed customer notices and filed tariff sheets to implement the WISRAs. The matters to be considered in this case and the

Commission's determinations thereon, could have a direct and significant impact on cost of service to large commercial and industrial customers.
