**ORDER GRANTING INTERVENTIONS AND
ORDER SETTING PREHEARING CONFERENCE**

On May 12, 2017, Missouri-American Water Company ("MAWC") filed the above-referenced application. MAWC seeks an accounting authority order ("AAO") for the cost of replacing the customers' portion of MAWC's lead service lines.

On May 30, 2017, the Commission received timely intervention requests from The Missouri Industrial Energy Consumers ("MIEC"), Midwest Energy Consumers Group ("MECG") and Consumers Council of Missouri. Commission Rule 4 CSR 240-2.080(13) allows parties ten days to respond to pleadings unless otherwise ordered. The Commission issued no order to the contrary, more than ten days have elapsed since those applications were filed, and no party has objected. Thus, the Commission will take up those applications unopposed.

Commission Rule 4 CSR 240-2.075(4) allows the Commission to grant intervention to a person who has an interest different from that of the general public and which may be adversely affected by a final order arising from the case, or if granting intervention would serve the public interest. Upon review of the unopposed applications, the Commission

finds that the applicants meet the standard in Commission Rule 4 CSR 240-2.075(4). Therefore, the Commission will grant the applications to intervene.

The Commission further finds that this is an appropriate time to set a prehearing conference.

THE COMMISSION ORDERS THAT:

1. The applications to intervene filed by The Missouri Industrial Energy Consumers, Midwest Energy Consumers Group, and Consumers Council of Missouri are granted.

2. The prehearing conference shall be held on June 28, 2017, beginning at 1:00 p.m., in Room 305 of the Governor Office Building, 200 Madison Street, Jefferson City, Missouri. That room is in a building that meets accessibility standards required by the Americans with Disabilities Act. Any person who needs additional accommodations to participate shall call the Public Service Commission's Hotline at 1-800-392-4211 (voice) or Relay Missouri at 711 before the conference.

3. Any party wishing to participate in the prehearing conference by telephone may do so by calling toll-free 877-820-7831, and entering PIN 80088928# at the time set for the beginning of the conference.

4. This order shall be effective when issued.
