COMES NOW Missouri-American Water Company (MAWC) and for its *Response to OPC Motion to Amend Hearing Schedule*, respectfully states to the Missouri Public Service Commission (Commission) as follows:

1. On February 24, 2023, the Office of the Public Counsel (OPC) filed its *Motion to Amend Hearing Schedule*. MAWC has no objection to moving the ROE/Capital Structure/Cost of Debt and Allowance for Funds Used During Construction issues from February 28, 2023, to March 9, 2023, as proposed by that Motion.


2. However, MAWC notes that travel arrangements have been set for most of its witnesses.
