## ORDER DIRECTING FILING

On February 26, 2023, Missouri-American Water Company (MAWC), on behalf of itself and other parties, filed a motion to suspend the procedural schedule. The Commission granted that motion on February 27, 2023.

On March 1, 2023, MAWC filed a Status Report. MAWC explains that a draft stipulation and agreement is circulating amongst the parties. If an evidentiary hearing is needed, MAWC states that the parties could try the disputed issues on March 9-10, 2023. MAWC also asks for the Commission to direct the parties to file either a stipulation or another status report no later than March 3, 2023.

The Commission finds MAWC's requests reasonable, and the Commission will grant them.

### THE COMMISSION ORDERS THAT:

1. The parties shall file a stipulation and agreement or a status report no later than March 3, 2023.
2. This order shall be effective when issued.
