On May 3, 2023, Missouri-American Water Company (MAWC) filed the above-referenced tariff sheets designed to implement a rate increase as allowed by the Commission's May 3, 2023 Report and Order. The tariff sheets bear an effective date of June 2, 2023.

MAWC also filed a Motion for Expedited Treatment in which it asks the Commission to approve the tariff sheets no later than May 28, 2023. The Commission will order its Staff to file a Recommendation, and will also allow other parties to respond.

1. The Commission's Staff shall file a Recommendation no later than May 12, 2023.
2. Any other party who wishes to respond shall do so no later than May 12, 2023.
