**ORDER POSTPONING IN-PERSON  
PORTION OF LOCAL PUBLIC HEARING**

The Commission has scheduled a combined in-person and virtual local public hearing in St. Louis for January 25, 2023. The St. Louis area is in a Winter Storm Watch, with four to seven inches of snow forecasted for late Tuesday night into Wednesday. Because of the forecast of hazardous weather, the Commission will postpone the January 25 in-person local public hearing.

The Commission will still conduct a virtual local public hearing on January 25, 2023. The Commission will attempt to reschedule the in-person portion of the hearing, and will notify the public of the new hearing date.

**THE COMMISSION ORDERS THAT:**

1. The January 25, 2023 in-person local public hearing in St. Louis is postponed. The Commission will still conduct a virtual local public hearing that evening at 6:00 p.m. by video, via WebEx, and telephone conference.

2. Members of the public may attend the hearing by telephone conference, which can be accessed by dialing, toll-free, 1 (855) 718-6621 and entering access code 2463 206 2918, followed by #, at the time set for hearing. Any individual who is unable to connect via the toll-free number may dial 1 (650) 479-3207 and enter the access code above, followed by #, at the time set for hearing.

3. Alternatively, those who wish to attend the hearing via Webex may do so by accessing Webex through the internet at [www.webex.com](http://www.webex.com), or via the Webex smartphone application, and selecting “join a meeting” from the menu. The hearing may be accessed via Webex by entering meeting number 2463 206 2918 and, when prompted, the password: 0303.

4. This order shall be effective when issued.
