ORDER RECOGNIZING TIMELINE EXTENSION

On June 13, 2022, Argyle Estates Water Supply (Argyle Estates) filed a letter initiating a staff assisted rate case under Commission Rule 20 CSR 4240-10.075. On June 21, Staff filed its *Small Utility Rate Case Timeline*, and on July 25, Staff filed a *Motion for Rate Case Timeline Extension*, explaining that Staff and Argyle Estates have agreed to a thirty-day extension and attaching an updated small utility rate case timeline.

Commission Rule 20 CSR 4240-10.075(5)(A) provides that Staff and the utility may agree in writing that the deadlines set out in the case timeline may be extended for up to thirty days, and that staff shall file the agreement and an updated timeline reflecting the extension in the case file. The Commission will recognize the updated timeline.

THE COMMISSION ORDERS THAT:

1. The Commission recognizes the parties' *Updated Small Utility Rate Case Timeline*.
2. This order shall be effective when issued.
