- 2 JUDGE THOMPSON: We're here for the resumption
- 3 of the hearing in Case WR-2003-0500, in the matter of
- 4 Missouri-American Water Company, the general rate case.
- 5 In order to have an idea of who is here this
- 6 morning, why don't we do oral entries of appearance. Don't
- 7 bother to tell me what your mailing address is. Just tell
- 8 me who you are and who you represent. We'll start with
- 9 Mr. Coffman and work our way through the room.
- 10 MR. COFFMAN: John B. Coffman on behalf of the
- 11 Office of the Public Counsel.
- JUDGE THOMPSON: Thank you.
- MR. KEEVIL: Jeffrey A. Keevil and Charles
- 14 Brent Stewart on behalf of the Empire District Electric
- 15 Company.
- JUDGE THOMPSON: Thank you.
- 17 MR. FISCHER: James M. Fischer representing
- 18 Public Water Supply Districts 1 and 2 of Andrew County and
- 19 Public Water Supply District No. 1 of DeKalb County.
- JUDGE THOMPSON: Thank you.

- JUDGE THOMPSON: Thank you.
- Okay. We are scheduled to begin opening

- 1 statements on rate design this morning, but I understand
- 2 that a motion is going to be made. Mr. Conrad, would you
- 3 like to step to the podium, sir?
- 4 MR. CONRAD: Sure, since there's not a
- 5 microphone back here and we certainly want the ships at sea
- 6 to hear.
- 7 JUDGE THOMPSON: I think our viewers in
- 8 Germany would appreciate it.
- 9 MR. CONRAD: Judge, there are a number of
- 10 things that have changed in this case since this group was
- 11 last together, not among the least of which are changes on
- 12 the Commission panel in the tragic situation, but also in a
- 13 tragic situation on the company witness who was an integral
- 14 part of this issue, as you know.
- 15 During the interim period and, in fact, while
- 16 the other processes were going on, a number of the parties
- 17 have continued to have meetings and discussions with respect
- 18 to the solution or a possible solution that would be
- 19 acceptable to all for what would be an otherwise very
- 20 complicated and very difficult issue to decide, namely that
- 21 of the rate design for now, I believe, either eight or nine
- 22 separate districts.
- Over the last holiday, several parties
- 24 exchanged e-mail and suggested, particularly after the
- 25 disclosure of the tragic loss of Company Witness Herbert's

- 1 wife that has prevented his attendance and the necessity to
- 2 reconfigure the schedule, several parties seemed to think
- 3 that it would be useful for the group to sit down on a
- 4 face-to-face basis, since the holidays have prevented people
- 5 from being able to consult in some instances with their own
- 6 expert because of people's schedules, but in any event with
- 7 each other in a possible attempt to see if there was a way
- 8 to resolve this.
- 9 The result of the discussions heretofore has
- 10 brought parties somewhat closer together, I think in some
- 11 instances particularly close, if not at a posture that
- 12 things have almost been resolved on a number of the
- 13 districts. There are a couple that are outstanding.
- 14 Given the circumstances, your Honor, with the
- 15 schedule and with the availability of the witnesses today,
- 16 and given the fact that it is now 10:36, at least by my
- 17 watch, it seemed to us, a number of us, to make some sense
- 18 to suggest to you that we would recess this process until,
- 19 say, at your discretion, 1:30 or 2 o'clock, at which point
- 20 we would reassemble here and report to you whether there had
- 21 been progress.
- I think others will indicate, as will I, that
- 23 there has been progress. We offer no solution here at this
- 24 point, but we think that further discussion might be
- 25 fruitful. If that's necessary to make in the form of a

- 1 motion, I would do that.
- 2 I think that will be -- my sense is that will
- 3 be generally supported and not opposed by most all, but I am
- 4 advised that one party will probably oppose this, being the
- 5 party that hasn't participated actively in the discussions
- 6 heretofore and also seems to not really have a constituency.
- 7 Most of the parties, indeed all of those that have actual
- 8 constituencies are, I think, in support of this motion.
- 9 Your Honor, I'll leave it at that point.
- 10 JUDGE THOMPSON: Thank you, Mr. Conrad.
- 11 Do I hear any objections to the motion that we
- 12 recess in order to permit an opportunity for settlement
- 13 discussions?
- MR. KRUEGER: Yes, your Honor.
- JUDGE THOMPSON: Mr. Krueger, why don't you
- 16 come to the podium and tell us all about your objection?
- 17 MR. KRUEGER: Mr. Conrad correctly predicted
- 18 that the Staff opposes this continuance. The case is
- 19 already far behind schedule, and we've known about the time
- 20 at which rate design was supposed to begin for quite some
- 21 time, a matter of months, and we believe that it's important
- 22 to proceed with this case and to move along so that it can
- 23 be finally submitted to the Commission.
- 24 The Staff, of course, is very saddened by the
- 25 death of Mr. Herbert's wife, and we're willing to make

- 1 accommodation for that by postponing his testimony 'til a
- 2 later time that's convenient for him and for the company.
- 3 But we think that we need to proceed with the presentation
- 4 of evidence today.
- JUDGE THOMPSON: Okay. Thank you,
- 6 Mr. Krueger.
- 7 I'm going to call a roll call of the parties,
- 8 and I'd like you to just advise me as to whether you support
- 9 the motion or object to the motion.
- 10 Mr. Coffman?
- 11 MR. COFFMAN: Yes, I'm very much in favor of
- 12 Mr. Conrad's motion to allow a wee bit more time to consider
- 13 the settlement discussions that have been ongoing for, at
- 14 least seriously for over a month.
- 15 JUDGE THOMPSON: Thank you. Mr. Keevil?
- MR. KEEVIL: I have no objection to the
- 17 motion, your Honor.
- JUDGE THOMPSON: Mr. Fischer?
- MR. FISCHER: Your Honor, I very much support
- 20 the opportunity to settle this if we can do so and save
- 21 three days.
- JUDGE THOMPSON: Mr. Finnegan?
- MR. FINNEGAN: I support it wholeheartedly,
- 24 your Honor, and point out also that since Mr. Herbert is
- 25 unavailable at this time, we are not going to lose that time

- JUDGE THOMPSON: Thank you. Mr. England?
- 4 MR. ENGLAND: We support the motion.
- JUDGE THOMPSON: Ms. Langeneckert?
- 6 MS. LANGENECKERT: The MEG supports the
- 7 motion.
- JUDGE THOMPSON: Thank you. Mr. Deutsch?
- 9 MR. ELLINGER: The City of Joplin supports the
- 10 motion and would like to see if we can conclude this with a
- 11 settlement on rate design.
- 12 JUDGE THOMPSON: Thank you, Mr. Ellinger. I
- 13 apologize for not calling you.
- MR. ELLINGER: That's okay.
- JUDGE THOMPSON: Mr. Zobrist?
- MR. ZOBRIST: The St. Joseph Water Rate
- 17 Coalition supports the motion.
- JUDGE THOMPSON: Mr. Curtis?
- 19 MR. CURTIS: City of Warrensburg fully
- 20 supports the motion.
- JUDGE THOMPSON: Mr. Comley?
- MR. COMLEY: No objection.
- JUDGE THOMPSON: Ms. Vuylsteke?
- 24 MS. VUYLSTEKE: We fully support the motion.
- JUDGE THOMPSON: And I apologize for garbling

- 1 your name if I did.
- 2 Mr. Krueger, does Staff have a witness who has
- 3 traveled from out of town for this presentation today?
- 4 MR. KRUEGER: No, your Honor, we do not.
- 5 JUDGE THOMPSON: So your witnesses are in the
- 6 building and they're not going to be seriously
- 7 inconvenienced if the recess is granted?
- 8 MR. KRUEGER: That's correct, your Honor.
- 9 JUDGE THOMPSON: Very well. The hearing will
- 10 recess in order to permit an opportunity for further
- 11 settlement discussions by all of the parties, and this room
- 12 will be available for your use. You may be able to find
- 13 other space in the building. I can't guarantee that, of
- 14 course.
- 15 The question then arises of what time to
- 16 reconvene. Mr. Conrad suggested one or two. Is that
- 17 sufficient time? Would you rather reconvene at three?
- 18 Would you rather come back tomorrow morning at nine? If
- 19 we're going to try to settle part of this case, then I want
- 20 you to have ample opportunity to settle part of this case.
- 21 MR. COFFMAN: Your Honor, I would suggest
- 22 that, given the complexity of the matter, that I would
- 23 prefer having the day to work it out, and perhaps if
- 24 something were to be worked out, to try to reduce it into
- 25 some comprehensible form by morning.

1	JUDGE THOMPSON: Okay. That's certainly my
2	inclination is to recess until tomorrow morning, with just
3	one further question to ask, which is whether there are
4	attorneys here who came down today to give an opening
5	statement that intended then to leave rather than remain for
6	the other proceedings and would be seriously inconvenienced.
7	Is there anyone who would put themselves in that category?
8	(No response.)
9	JUDGE THOMPSON: Evidently there is not.
10	Okay. We will recess this hearing until tomorrow morning at
11	nine o'clock. Thank you.
12	WHEREUPON, the hearing of this case was
13	recessed until January 6, 2004.
