2	JUDGE STEARLING: Good afternoon. It is
3	March 6, 2012, and the Commission has set this time for an
4	on-the-record proceeding to direct questions to the parties
5	regarding a stipulation agreement that's been filed here in
6	File No. WR-2011-0337, which is captioned as In the Matter
7	of Missouri-American Water Company's Request for Authority
8	to Implement a General Rate Increase for Water and Sewer
9	Service Provided in Missouri Service Areas.
LO	My name is Harold Stearley, and I'm the
L1	regulatory law judge presiding over today's proceeding.
L2	And we'll begin by taking entries of appearance, starting
L3	with Missouri-American Water Company.
L 4	MR. COOPER: Dean Cooper from the law firm
L5	of Brydon, Swearengen & England, P.C., P.O. Box 456,
L 6	Jefferson City, Missouri 65102, appearing on behalf of
L7	Missouri-American Water Company.
L8	JUDGE STEARLEY: Thank you, Mr. Cooper.
L 9	For Utility Workers Union of American,
20	Local 335?
21	Okay. Hearing none, Triumph Foods?
22	MS. GILBREATH: Lisa Gilbreath appearing on
23	behalf of Triumph Foods, LLC, SNR Denton US, LLP, 4520 Main

Street, Kansas City, Missouri 64111.

JUDGE STEARLEY: Thank you, Ms. Gilbreath.

- 2 MR. CONRAD: Your Honor, please let the
- 3 record show the appearance of Stu Conrad, Finnegan Conrad &
- Peterson, LLC; Kansas City. And I have not, but I will get
- 5 the detail to her later.
- JUDGE STEARLEY: Thank you, Mr. Conrad.
- 7 For the Empire District Electric Company?
- 8 MR. JOHNSON: Thank you, your Honor. Craig
- 9 Johnson, Johnson & Sporleder, 304 East High, Suite 200,
- Jefferson City, Missouri, for the Empire District Electric
- 11 Company.
- 12 JUDGE STEARLEY: Thank you, Mr. Johnson.
- 13 BJC HealthCare?
- MS. LANGENECKERT: Thank you, Judge
- 15 Stearley. Lisa Langeneckert, appearing on behalf of BJC
- 16 HealthCare. I have given the court reporter my

- JUDGE STEARLEY: All right. Thank you,

- JUDGE STEARLEY: All right. Thank you,
- 7 Ms. Baker.
- 8 City of Warrensburg? Mr. Curtis had
- 9 contacted me and said he would not be attending today.

- 11 MR. STEINMEIER: Thank you, your Honor.
- 12 Please let the record reflect the appearance of William D.
- 13 Steinmeier, William D. Steinmeier, P.C. of Jefferson City,
- on behalf of the City of St. Joseph.
- 15 JUDGE STEARLEY: Thank you, Mr. Steinmeier.
- The City of Joplin? Okay. No entry for the
- 17 City of Joplin.
- 18 The City of Jefferson? No entry for Jeff
- 19 City.
- The City of Riverside?
- MR. BEDNAR: Joe Bednar, of Spencer Fane
- 22 Britt & Browne, appearing on behalf of the City of
- 23 Riverside. The address is 308 East High Street, Jefferson

- JUDGE STEARLEY: Thank you, Mr. Bednar.

- 1 For the Metropolitan St. Louis Sewer
- 2 District?
- 3 MR. FRANCIS: Thank you, your Honor. It's
- 4 Byron Francis, Armstrong Teasdale, LLP, 7700 Forsyth
- 5 Boulevard, Suite 1800, St. Louis, Missouri 63105, appearing
- on behalf of St. Louis Metropolitan Sewer District.
- JUDGE STEARLEY: Thank you, Mr. Francis.
- 8 City of Brunswick?
- 9 MR. DORITY: Thank you, Judge. Larry Dority
- of Fischer & Dority, P.C., 101 Madison Street, 400,
- 11 Jefferson City, Missouri 65101, appearing on behalf of the
- 12 City of Brunswick, Missouri and the Public Water Supply
- 13 District Nos. 1 and 2 of Andrew County.
- JUDGE STEARLEY: Thank you, Mr. Dority.
- 15 For the Staff of the Missouri Public Service
- 16 Commission?
- 17 MS. LEWIS: Thank you, Judge. Rachel Lewis
- and Kevin Thompson on behalf of Staff of the Public Service
- 19 Commission, P.O. Box 360, Jefferson City, Missouri 65102.
- JUDGE STEARLEY: Thank you, Ms. Lewis.
- 21 For preliminary matters, we have had a
- 22 couple of findings asking for leave to late file a
- 23 designation of witnesses to be available, and those are all
- 24 granted.
- I did want to note with regard to MIEC, for

- 1 the record, Ms. Vuylsteke, Mr. Meyer was not a witness to
- prefiled testimony in this case?
- MS. VUYLSTEKE: That is correct, your Honor.
- 4 JUDGE STEARLEY: All right. And I don't
- 5 know the parties have pretty much waived cross of people
- 6 who have prefiled testimony. And I don't know that we're
- 7 going to be getting into a lot of contentious questioning,
- 8 but some of the other parties may have desired to direct
- 9 some questions toward Mr. Meyer since he hasn't offered
- 10 testimony before in this --
- 11 MS. VUYLSTEKE: There will be time, your
- 12 Honor.
- 13 JUDGE STEARLEY: Okay. Thank you. Any
- other preliminary matters we need to take up?
- 15 MR. CONRAD: Well, your Honor, I think I had
- 16 burdened your telephone earlier that I have kind of a --
- 17 yesterday, that Mr. Johnson would be here, and he is. But
- I did not have the opportunity to put the pleadings
- 19 together so --
- JUDGE STEARLEY: That's quite all right.
- 21 We're glad to have him. Thank you, Mr. Conrad.
- 22 What I'm going to do is I'm going to mass
- 23 swear in the witnesses. So I believe we have Jim Busch for
- 24 Staff and Kim Bolin for Staff; Dennis Williams for MAWC;
- 25 Barbara Meisenheimer for OPC; Mark Oligschlaeger, also for

- 1 Staff; Greq Meyer for MIEC; and Donald Johnstone then for
- 2 AG Processing. If you'd all please raise your right hands.
- 3 (Witnesses sworn.)
- 4 JUDGE STEARLEY: Thank you very much. Since
- 5 I have mass sworn you-all in, as the Commissioners direct
- 6 questions to you, if you would please identify yourself
- 7 before answering so our court reporter can know who's
- 8 speaking.
- 9 Very well. Commissioners, questions on the
- 10 stipulation? Unless anyone would like to make an opening
- 11 statement first.
- 12 COMMISSIONER GUNN: If I could just direct
- 13 this to Public Counsel real quick. Although the actual
- dollar amounts for some of the districts are not enormous,
- some of the percentage increases are big in some of the
- 16 districts.
- So I just want to make it perfectly clear
- that you're comfortable with the stipulation agreement, you
- 19 believe that the raises to the particular districts that
- are specified in the appendix of the stipulation,
- 21 especially to the residential consumers, are fair and
- 22 supported by the evidence, and you support as a signatory
- 23 to the stipulation agreement.
- MS. BAKER: We do support it as the
- 25 signatory and we do believe that the rates that have come

- 1 out of this are fair and justified.
- COMMISSIONER GUNN: The City of Joplin is
- 3 not here. Correct?
- I'm going to ask that the parties -- and I
- 5 know no one is speaking for Joplin, but I will ask that the
- 6 parties state that the attorneys for Joplin and the City of
- 7 Joplin has had an opportunity to review the stipulation.
- 8 They've had the resources to review the stipulation and
- 9 they are not a signa-- have they signed on?
- 10 MS. LEWIS: No. They have not.
- 11 COMMISSIONER GUNN: They are not a
- 12 signatory, but that they -- I'm going to ask everyone else
- 13 to make that representation, that they have been fully and
- 14 fairly apprised of the contents of the stipulation, that
- 15 they don't object to the stipulation, and they have not
- 16 requested a hearing. Is that all the parties'
- 17 understanding?
- 18 UNIDENTIFIED SPEAKERS: Yes.
- 19 COMMISSIONER GUNN: Okay. I just want to
- 20 make that perfectly clear. The Unions are not represented
- 21 here as well; is that correct?
- JUDGE STEARLEY: That's correct.
- 23 COMMISSIONER GUNN: And the stipulation
- doesn't mention any of the Union issues, but they
- 25 also -- and I'm just doing a lot of this for the record.

- 1 They also have had an opportunity to review the stipulation
- 2 and they've filed a separate pleading stating that they do
- 3 not object and did not request a hearing on those issues in
- 4 this matter. Correct?
- 5 UNIDENTIFIED SPEAKERS: Correct.
- 6 COMMISSIONER GUNN: Let the record reflect
- 7 that all the parties agreed.
- 8 Let's see. Warrensburg eventually signed
- 9 on, although they were not an original signatory. That's
- 10 correct?
- MS. LEWIS: Correct.
- 12 COMMISSIONER GUNN: Okay. I think that's
- 13 all I had. It's my understanding that all of the districts
- 14 will see a slight increase, except for Water District
- 15 Eight. Am I correct in that, that they're -- because there
- are blocked rates and commodities charges, there are
- 17 some -- some of those contain -- and district eight though
- 18 will see some significant decreases.
- 19 MR. BEDNAR: I would -- I would just -- I
- 20 don't know that I would characterize it as slight
- 21 increases.
- 22 COMMISSIONER GUNN: I will --
- 23 MR. BEDNAR: That would be the clarification.
- 24 COMMISSIONER GUNN: You're absolutely
- 25 correct. All the other districts have increases. I will

- leave it at that. Although, there appear to be decreases
- 2 in District -- for water in District Eight. Am I correct
- 3 in that?
- 4 And all the increases in other districts
- 5 are, as a percentage-wise, they are consistent within those
- 6 particular districts. Correct?
- 7 So there is -- and let's look at Joplin in
- 8 Appendix Eight. They have a percentage increase,
- 9 10.07 percent, which is consistent across the board in all
- 10 classes and in all the blocks.
- MS. MEISENHEIMER: Yes.
- 12 COMMISSIONER GUNN: And that's consistent
- with all the districts, except for District Eight, which is
- 14 an amalgamation of small municipalities and smaller cities.
- 15 MS. MEISENHEIMER: Yes. And with the
- 16 exception of the Roland Fire adjustments in St. Louis, the
- 17 St. Louis Metro District. That is correct.
- 18 COMMISSIONER GUNN: I don't think I have any
- other questions. Thank you all. Let me just say real
- 20 quick: I want to commend everybody because we had an
- 21 extraordinary amount of parties in this case, and there
- were a lot of tough issues here.
- 23 And the ultimate resolution that was
- 24 approved to by most of the parties, and not objected to by
- 25 the others, took some creativity on behalf of the parties.

- 1 And by not accepting one -- or not being meted to one
- 2 person's solution, and being able to work through that and
- 3 come up with what appears to be a workable hybrid of a lot
- 4 of different ideas is impressive.
- 5 And what I believe is the way that a lot of
- 6 this stuff should be done, where we appear to have come to
- 7 a result that -- and I warned the judge I might do this
- 8 earlier, to quote the great Bruce Springsteen, Ain't a
- 9 beauty, but, hey, you're all right. So I think that we've
- 10 gotten to the point where nobody is probably as happy as
- 11 you can be, but everyone is satisfied enough from
- 12 everything you've done.
- 13 So I appreciate the work that was done. I
- 14 appreciate it very much. I'm assuming -- Professor Conrad,
- if you wanted to stand up and --
- 16 MR. CONRAD: You're kind, Mr. Chairman, and
- 17 I would echo your sentiments. I think it does deserve to
- be said, though, that the work that was done, in this
- 19 regard and in putting this package together, by the Office
- of the Public Counsel and by Ms. Meisenheimer, I think they
- 21 deserve some additional lifting up because of the level of
- 22 work that they were able to do.
- Obviously, we think we had some input into
- 24 it, but I think ultimately they -- they pretty much carried
- 25 the day. And they do have the largest group of clients

- 1 here, as you well know.
- 2 COMMISSIONER GUNN: Absolutely.
- MR. CONRAD: You're quite correct that a
- 4 compromise has no father, has no mother. I'm not as
- 5 familiar as you with Bruce Springsteen; I think he starred
- 6 in Star Trek.
- 7 COMMISSIONER GUNN: Close enough.
- 8 MR. CONRAD: Thank you.
- 9 COMMISSIONER GUNN: Thank you. And that is
- 10 noted for the record, the work that Public Counsel did, so
- 11 thanks very much. So I don't have anything further.
- 12 JUDGE STEARLEY: Commissioner Jarrett?
- 13 COMMISSIONER JARRETT: Thank you, Judge.
- 14 First of all I want to commend the Chairman for Thunder
- 15 Road reference. Very well placed. Did you have a bet with
- 16 somebody that you --
- 17 COMMISSIONER GUNN: I'm collecting five
- 18 bucks later, but I'm not telling from who.
- 19 COMMISSIONER JARRETT: And I want to echo
- 20 Chairman Gunn's sentiments as well. Looking over the
- 21 diverseness of the parties in this case and how you were
- 22 able to come up with a complete global agreement is very
- 23 commendable, and I commend you on the hard work that you've
- done. I think it's probably the most diverse group that
- 25 I've seen in a settlement stipulation and agreement in my

- four and a half years here on the Commission. So
- 2 congratulations for that.
- I only have one question and this is -- I'll
- 4 throw it out for all of the sworn witnesses: Do all of you
- 5 believe that this leads to safe and reliable service at
- 6 just and reasonable rates?
- 7 MS. MEISENHEIMER: Yes, I do.
- 8 UNIDENTIFIED SPEAKERS: Yes.
- 9 COMMISSIONER JARRETT: All right. Let the
- 10 record reflect that all the witnesses agreed with that
- 11 statement.
- 12 So with that, I don't have any further
- 13 questions. Again, thanks and congratulations to all of you
- for coming up with what looks like a good workable
- 15 agreement.
- 16 JUDGE STEARLEY: All right. If the
- 17 Commissioners have no further questions, do the parties
- have anything we need to address at this time?
- 19 Hearing none --
- MR. STEINMEIER: Your Honor, I just want to
- 21 also tip my hat to Staff. I mean, everybody in the room
- 22 played a role in what really was, in my experience, a
- 23 remarkable process. But at the end of the day, every time
- 24 somebody comes up with a creative possible solution, there
- 25 are a whole lot of numbers that get to be run, details that

Τ	get to be worked out, and a whole lot of those get done by
2	the Commission Staff.
3	So a lot of extra hours under pressure were
4	applied by the Staff as well, and with my hat off as well
5	to Public Counsel and to every party to the case. I didn't
6	want to let Staff go unrecognized.
7	JUDGE STEARLEY: Thank you, Mr. Steinmeier.
8	Anything else? All right. Well, hearing none, I
9	appreciate you-all coming. The plan is to have an Order on
10	tomorrow's agenda. Since there's nothing more to take up
11	at this time, we stand adjourned.
