**ORDER SUSPENDING TARIFF, DIRECTING NOTICE, SETTING INTERVENTION  
DEADLINE, AND DIRECTING FILING OF STAFF RECOMMENDATION**

On August 21, 2018, Missouri-American Water Company (“MAWC”) filed P.S.C. Mo. No. 13, 2nd Revised Tariff Sheet No. R. 65 to replace the 1st Revised Tariff Sheet No. R. 65. The tariff has an effective date of September 20, 2018. The tariff sheet changes how MAWC accounts for income taxes that accrue from Contributions in Aid of Construction.

On August 24, 2018, the Commission’s Staff filed a motion to suspend the tariff. Staff requests the Commission suspend this tariff and conduct proceedings to determine whether to adopt or reject the proposed tariff. Ten days have passed and no responses to Staff’s motion were received. The Commission will suspend the tariff, issue notice, set a deadline for intervention requests, and direct the Commission’s Staff to file a recommendation.

**THE COMMISSION ORDERS THAT:**

1. The tariff sheet filed by Missouri-American Water Company on August 21, 2018, and assigned tariff tracking number JW-2019-0019, is suspended until November 7, 2018. The tariff sheet suspended is:
