1. Staff filed its *Petition for an Interim Receiver* ("*Petition*") in the above-styled matter on March 14, 2017, seeking an order from the Missouri Public Service Commission ("Commission") appointing an interim Receiver of Ridge Creek Water Company, LLC ("*Water Company*"), and Ridge Creek Development L.L.C. ("*Development Company*"), and directing the General Counsel to pursue the same in circuit court.

2. The Commission issued its *Notice of Petition for Appointment of Receiver, and Order Scheduling a Procedural Conference* ("*Notice*") to Respondents on March 15, 2017.

3. Upon review of the EFIS Docket entries, Staff notes that it appears *Notice of Service* has not been completed for Respondent Development Company.
