On September 14, 2021, the Commission directed the parties to state how they believe the Commission should proceed with this matter on or before September 29, 2021. The Commission expressed a preference for a joint filing. To that end, the parties jointly requested an extension of time of two weeks to file a response, which the Commission granted.

On October 13, 2021, the parties filed a request for an additional week's extension. The parties state they have generally agreed as to the amount at issue, and are still discussing the methodology to address that amount. The parties believe an additional week for discussions would be helpful.

The Commission finds the joint request reasonable and will grant it.
