## ORDER SETTING TIME FOR REPLIES

On December 13, 2021, Missouri-American Water Company (MAWC) filed its response to the Staff of the Commission's (Staff) recommendation and the Office of the Public Counsel's (OPC) objection and recommendation. MAWC indicates that Staff is now in agreement with MAWC that its water and sewer infrastructure rate adjustment (WSIRA) rates should be designed to recover annual revenues of \$16,135,000 for St. Louis water, \$2,659,795 for All Other water, \$42,491 for Arnold sewer, and \$165,495 for All Other sewer for a total of \$19,002,781. Additionally, MAWC indicates that it will make the changes to the tariff as proposed by OPC in its recommendation. MAWC also filed a revised customer notice and exemplar tariff sheets that includes the changes identified by Staff and OPC.

It appears from MAWC's filing that there is no longer a disagreement regarding the recovery of WSIRA rates and the Commission may consider this request with the noted changes to be unopposed. To verify there is no further disagreement, the Commission will set a deadline for the filing of replies to MAWC's December 13, 2021 filing.

**THE COMMISSION ORDERS THAT:**

1. Any reply to the December 13, 2021 response of MAWC shall be filed no later than December 28, 2021.
2. This order shall be effective when issued.
