ORDER DIRECTING RESPONSE

On January 4, 2023, the Commission approved a stipulation and agreement to implement an adjustment to Missouri-American Water Company's Water and Sewer Infrastructure Act rates. The Commission's order rejected the tariffs previously filed by Missouri-American, but authorized the company to file new tariffs consistent with the approved stipulation and agreement. Missouri-American filed new tariffs on January 4, accompanied by a motion asking that the tariffs be approved for service on and after January 16, as contemplated in the approved stipulation and agreement.

The Commission will direct its Staff to review the tariff filings to ensure that they comply with the approved stipulation and agreement.

THE COMMISSION ORDERS THAT:

1. Staff shall file a recommendation regarding the compliance tariffs filed by Missouri-American no later than 1:00 p.m. on January 6, 2023.
2. Any other party wishing to respond to the compliance tariffs filed by Missouri-American shall do so no later than 1:00 p.m. on January 6, 2023.
3. This order shall be effective when issued.
