NOTICE OF AGREEMENT

COMES NOW Missouri-American Water Company (MAWC or Applicant), and hereby notifies the Missouri Public Service Commission (Commission) of MAWC's Agreement with the Commission Staff (Staff) Recommendation filed on March 20, 2007.

1. On March 20, 2007, the Staff filed a Recommendation that contained a Memorandum describing Staff's review of MAWC's Petition.
2. Having reviewed the March 20, 2007, Staff Recommendation, Memorandum and attachments thereof, MAWC hereby notifies the Commission that it is in agreement with the recommendations contained in the Staff Memorandum (Appendix A) and asks that the Commission issue an order as requested by the Staff.
3. The Commission previously suspended MAWC's proposed ISRS tariff sheet (YW-2007-0496) until May 19, 2007. Because there appears to be no disagreement among the parties and no necessity for a hearing, MAWC would ask the Commission to act at its earliest convenience.

WHEREFORE, for the foregoing reasons, MAWC respectfully requests the Commission accept this Notice of Agreement and thereafter issue an Order authorizing MAWC to implement the Infrastructure System Replacement Surcharge tariff sheet pending in Tariff File No. YW-2007-0496 to be effective on May 19, 2007, or as of the effective date of the Commission's Order approving that tariff sheet if that date is sooner.


