## ORDER DIRECTING RESPONSE REGARDING LOCAL PUBLIC HEARING

On March 8, 2022, S. K. & M. Water and Sewer Company filed a letter requesting an increase in its annual water system operating revenues in a staff assisted rate case under Commission Rule 20 CSR 4240-10.075.<sup>1</sup> Subsection 6 of the rule requires a local public hearing to be scheduled to occur no later than 60 days after the opening of the case, unless all parties agree that a local public hearing is not necessary. In this case, that deadline is May 6, 2022.

The Commission will direct the parties to file a response recommending locations and dates for a local public hearing.

### THE COMMISSION ORDERS THAT:

- 1. No later than March 22, 2022, the parties in this case shall file a joint response listing recommended dates and locations for a local public hearing.
  - 2. This order shall be effective when issued.
