On April 4, 2023, Raytown Water Company (the Company) filed a letter requesting an increase in its annual overall operating revenues in a staff assisted rate case. - 4. No later than ten days before the local public hearing, the Company shall provide notice of the hearing to each of its customers.
- 5. Any person may comment at the hearing. To facilitate an orderly presentation that can be preserved for the record, members of the public who wish to participate in the hearing shall register by sending their first and last name, phone number, and email address to watersewercomments@psc.mo.gov, or by calling (800) 392-4211 no later than 5:00 p.m. the day before the hearing, May 22, 2023.
