STAFF RECOMMENDATION

COMES NOW, Staff of the Missouri Public Service Commission (Staff), by and through counsel, and for its *Staff Recommendation*, states as follows:

- 1. On November 8, 2019, Missouri-American Water Company (MAWC or Company) filed two proposed tariff sheets seeking to revise the billing procedures of its private fire protection services. These tariffs sheets were assigned tracking number JW-2020-0076, and bore effective dates of December 8, 2019. Subsequently, Staff filed its *Motion to Suspend Tariff Sheets and Open a New Docket*, pursuant to Commission Rule 20 CSR 4240-2.065. In consideration of MAWC's preference to incorporate potential changes into its current billing practices prior to issuing bills for calendar year 2020, Staff stated in its *Motion* that it would complete its review as quickly as practically possible.
- 2. While the Commission has opened a new docket, it has not yet suspended the Company's proposed tariff sheets or directed its Staff to file a recommendation in this matter. That being said, Staff has reviewed the Company's proposed tariff sheets filed on November 8, 2019, and is of the opinion that they are appropriate and should be approved.
- 3. The proposed revised tariff sheets will provide MAWC's customers in St. Louis County that utilize private fire protection services the option of being billed monthly, as opposed to annually, allowing for flexibility in how and when they are billed

for service. James A. Busch, the Regulatory Manager of the Water & Sewer Department of the Commission, performed the review of the subject revised tariff sheets on behalf of the Staff.

WHEREFORE, the Staff respectfully recommends that the Commission issue an order allowing the following revised tariff sheets to take effect as soon as is reasonable; and grant such other and further relief as the Commission deems just in the circumstances:

- P.S.C. Mo. No. 13, 5th Revised Sheet No. RT 3.1 Cancelling the 4th Revised Sheet No. RT 3.1
- P.S.C. Mo. No. 13, 4th Revised Sheet No. RT 3.2 Cancelling 3rd Revised Sheet No. RT 3.2.
