COMES NOW Missouri-American Water Company ("MAWC"), by and through the undersigned counsel, and, as its *Notice*, states as follows to the Missouri Public Service Commission ("Commission"):

1. On November 17, 2021 (effective January 2, 2022), the Commission issued its *Order on Remand* wherein it ordered that MAWC provide a refund in the total amount of \$19,172 to its Rate A customers in St. Louis County. The refund was to begin on January 2, 2022, on a "per customer" basis (and be completed no later than March 31, 2022). This one-time bill credit was to be in the amount of \$0.06 per St. Louis County Rate A customer (as was rounded up). MAWC completed the application of the refund to customer accounts in February 2022.¹

2. The *Response to Order Directing Filing* filed on October 20, 2021, further explained that MAWC had filed a request for Private Letter Ruling (PLR) with the Internal Revenue Service in light of the Court action in this matter. MAWC received the requested PLR on April 12, 2022. That PLR is attached hereto as <u>Appendix A</u>. Appendix A has been identified as Confidential in accordance with Commission Rule 20 CSR 4240-2.135(2)(A)5. The PLR indicates that a normalization violation does not exist for MAWC under the circumstances described therein.

¹ There were 178 customer accounts that had been closed. The total amount refunded was \$20,122.36.

WHEREFORE, MAWC respectfully requests that the Commission consider the information provided herein.
