#### ORDER CONSOLIDATING FILES

On March 23, 2022, the Commission's Staff filed a motion in these two files asking the Commission to open an investigation into the operations and condition of the water and sewer systems of Liberty Utilities (Missouri Water), LLC d/b/a Liberty Utilities. The Commission opened these investigative cases in an order issued on March 30, 2022. On March 28, 2022, Staff filed a motion asking the Commission to consolidate these two cases, with WO-2022-0253 being the lead case.

Commission Rule 20 CSR 4240-2.110(3) allows the Commission to consolidate pending actions involving related questions of law or fact. The Commission finds that Staff's Motion to Consolidate should be granted, and these two investigations regarding water and sewer service should be consolidated for all purposes.

#### THE COMMISSION ORDERS THAT:

- 1. File Numbers WO-2022-0253 and SO-2022-0254 are consolidated for all purposes, with File Number WO-2022-0253 being designated as the lead case.
