On March 30, 2022, the Commission ordered its Staff to conduct an investigation into the operation and condition of Liberty Utilities (Missouri Water), LLC d/b/a Liberty Utilities (Liberty Water). Staff filed its report on November 23, 2022, including multiple recommended actions to be taken by Liberty Water. The Commission will establish a date for Liberty Water to respond to Staff's report.

THE COMMISSION ORDERS THAT:

1. Liberty Water shall respond to Staff's report no later than December 30, 2022.
2. Any other stakeholder wishing to respond to Staff's report shall do so no later than December 30, 2022.
3. This order shall be effective when issued.
