ORDER GRANTING MOTION FOR EXTENSION OF TIME AND SETTING TIME FOR RESPONSES

The Territorial Agreement between Missouri-American Water Company and Audrain Public Water Supply District No. 1 was approved by the Commission on April 6, 2017, effective May 6, 2017. The order approving the agreement directed Missouri-American to submit a revised tariff sheet within ten days of the effective date of the order. On May 24, 2017, however, Missouri-American requested a 30-day extension of time in which to file those tariff sheets due to issues in finalizing the Asset Purchase Agreement. No party has responded to the request for an extension and more than ten days has passed.

Having reviewed the motion and finding it reasonable, the Commission will grant the extension of time.

THE COMMISSION ORDERS THAT:

- The motion for extension of time filed by Missouri-American Water
 Company on May 24, 2017 is granted.
- 2. The Missouri-American Water Company shall file its tariff no later than June 26, 2017.

- 3. The Staff of the Missouri Public Service Commission shall file a response and recommendation regarding the compliance tariff no later than 10 days following the date on which the tariff is filed.
- 4. Any responses to the tariff shall be filed no later than 10 days after the date on which the tariff is filed.
 - 5. This order shall be effective when issued.
