**ORDER DIRECTING FILING**

On December 6, 2017, the Commission issued an Order Approving Stipulation and Agreement (“Order”). The Order rejected a tariff Missouri-American Water Company (“MAWC”) filed. The Order further authorized MAWC to file a tariff to change its Infrastructure System Replacement Surcharge (“ISRS”) as the parties agreed in their Stipulation and Agreement.

Also on December 6, 2017, after the Commission issued the Order, MAWC filed a new tariff, denominated Tariff No. YW-2018-0073. That tariff is designed to implement the ISRS the Commission approved earlier that day in the Order.

The tariff bears an effective date of January 5, 2018. However, MAWC also filed a Motion for Expedited Treatment (“motion”), in which it asks the Commission to approve the new ISRS effective December 15, 2017. In the motion, MAWC points out that the parties agreed the new ISRS should become effective on December 15, 2017.

The Commission will order its Staff to file a Recommendation, and will allow other parties an opportunity to respond to the tariff and motion.

**THE COMMISSION ORDERS THAT:**

1. The Staff of the Commission shall file a Recommendation no later than December 8, 2017.
2. Any other party who wishes to respond to the Tariff No. YW-2018-0073 or the Motion for Expedited Treatment shall do so no later than December 8, 2017.
3. This order shall be effective when issued.
