## ORDER GRANTING TWO WEEK EXTENSION

On September 14, 2021, the Commission directed the parties to state how they believe the Commission should proceed with this matter on or before September 29, 2021. The Commission expressed a preference for a joint filing. To that end, the parties jointly requested an extension of time of two weeks to file a response. The parties believe additional discussions would be helpful.

The Commission finds the joint request reasonable and will grant it. However, the Commission notes that Section 386.520.2(2), RSMo, sets a time limit of sixty days (one hundred twenty days when additional time is necessary) for the Commission to issue an order on remand. Therefore, the parties should factor that timeline into any procedure they recommend.

### THE COMMISSION ORDERS THAT:

1. The due date for the response(s) referenced in the body of this order is extended to on or before October 13, 2021.
2. This order shall be effective when issued.
