2 JUDGE MILLS: Okay. Let's go on the
3 record. We're on the record this morning for a
4 pre-hearing conference in WO-2005-0086. We'll
5 begin by taking entries of appearance, starting
6 on my left with the Staff.

7 MR. SNODGRASS: Thank you very much,
8 judge. My is Cliff Snodgrass. I represent the
9 interests of the Staff of the Missouri Public
10 Service Commission today. My formal business
