## ORDER GRANTING APPLICATIONS TO INTERVENE

On September 3, 2021, Missouri-American Water Company (MAWC) filed its petition to establish water and sewer infrastructure rate adjustments (WSIRAs) under Sections 393.1500-1509, RSMo. MAWC also requested that the Commission approve its proposed customer notices and filed tariff sheets to implement the WSIRAs. On September 9, 2021, the Commission suspended the tariff sheets until March 2, 2022, set deadlines for intervention requests, Staff's recommendation and objections to the application. On September 28, 2021, the Midwest Energy Consumers' Group (MECG) and the City of St. Joseph, Missouri, filed a timely applications to intervene.

More than ten days have passed since the applications were filed and no one has responded. After considering the unopposed applications to intervene, the Commission finds that MECG and the City of St. Joseph have interests that are different from those of the general public and allowing them to intervene will serve the public interest. Therefore, in accordance with Commission Rule 20 CSR 4240-2.075(3), the Commission will grant the applications to intervene.

### THE COMMISSION ORDERS THAT:

1. The applications to intervene of MECG and the City of St. Joseph, Missouri, are granted.

2. This order shall be effective when issued.
