The purpose of this Memorandum and the attached document is to provide the Commission and interested underground facility damage prevention stakeholders with a summary of the excavation damages and excavation notifications that natural gas operators subject to the Commission's safety jurisdiction have experienced/received over the past four calendar years.

The information presented in the attached document comes from the report that natural gas operators submit annually to the Commission's pipeline safety program staff. Other than the information obtained through responses to the 08/17/09 Underground Facility Damage Assessment Survey, which was previously submitted to EFIS File No. GW-2010-0120, similar information is not routinely provided by other Commission-regulated underground facility owners.
