1		<u>REBUTTAL TESTIMONY OF ELIZABETH E. WOTAWA</u>
2	Q.	Please state your name and business address.
3	A.	My name is Elizabeth E. Wotawa, and my business address is 720 Olive St., St. Louis,
4		Missouri, 63101.
5	Q.	Are you the same Elizabeth E. Wotawa who previously filed direct testimony in this case
6		on behalf of Laclede Gas Company ("Laclede" or "Company")?
7	A.	Yes.
8		PURPOSE OF TESTIMONY
9	Q.	What is the purpose of your rebuttal testimony?
10	A.	The purpose of my testimony is to respond to the following adjustments by Commission
11		Staff ("Staff") witnesses Erin Carle and Lisa Hanneken:
12		1. <i>Dues and Donations</i> . I will describe those expenses removed from the test year in
13		Staff's Dues and Donations adjustment that benefit Laclede's customers and
14		therefore merit recovery in this case.
15		2. Medical Inflation. I will describe an adjustment to Staff's level of normalized
16		medical expense which reflects not only Staff's adjustment for the reduction in
17		contract employees but also Laclede's increased costs due to medical inflation.
18		3. <i>Health Care Reform Act.</i> I will describe the adjustments necessary to reflect the
19		known and measurable impact of the Health Care Reform Act on Laclede's
20		medical expenses.
21		4. <i>Treasury Account Special.</i> I will respond to Staff's treatment of the normal and
22		customary expenses of Laclede's officers.
23	Q.	Please list the schedules you are sponsoring.

- A. I am sponsoring Schedule EEW-1, which provides support to my discussion of Dues and
   Donations.

#### 4 A. Dues and Donations

5 Q. Please describe your review of Staff's Dues and Donations adjustment.

A. My analysis of Staff's Dues and Donations adjustment is based on my review of the work
papers Laclede received on this issue from Staff witness Erin Carle. I have identified
several expenses which merit inclusion in Laclede's rates; for convenience I have
organized these items into five categories based on the benefit they provide to Laclede's
customers:

- 1. Low-income assistance programs. The expenses I identified in this category 12 pertain primarily to two activities: Laclede's efforts to inform customers about 13 Dollar-Help and Laclede's efforts to network with the agencies that pledge funds 14 for bill assistance. Laclede's low-income customers benefit directly from the 15 funds raised through these programs, and, to the degree that these funds mitigate 16 uncollected revenue, Laclede's customer base benefits from a lower level of 17 uncollectible revenue in rates.
- 2. *Business operations.* The expenses I identified in this category ensure that In Laclede's employees have access to education, training, certification and other resources that allow the Company to conduct its business in an efficient and costeffective manner. The business areas include collections, legal, corporate governance, safety, environmental regulation, industry standards, control of health care expenses, and investor relations.

1	3.	Energy conservation initiatives. In previous rate cases Laclede has made the
2		commitment to encourage its customers to lower their natural gas bills through
3		energy conservation. The costs in this category relate to Laclede's efforts to
4		identify appliances and practices which use natural gas more efficiently and the
5		Company's efforts to communicate this knowledge to customers and developers.

- 6 4. *Community investment*. Laclede participates in community organizations to
  7 improve the business and social environment in its service territory, a factor that
  8 can have a direct effect on the cost of utility service to its customers.
- 9 5. *Safety*. Laclede customers benefit from the Company's safety-related expenses to 10 the degree that the Company can limit its exposure to accidents and injuries in the 11 workplace.

12 Schedule EEW-1 provides a detailed list of these expenses.

Q. What is the impact of the items detailed in EEW-1 on Staff's Dues and DonationsAdjustment?

A. Please see the table below, which details Laclede's and Staff's adjustments to test year expenses. The first column presents Laclede's initial-filing adjustment to test year for dues and donations expenses; the second column is Staff's adjustment to test year in excess of Laclede's adjustment.

2 Q. What does the "Laclede Rebuttal" column represent?

A. After a review of Staff's disallowance, Laclede identified several expenses which, in the
 Company's opinion, provide a benefit to customers for the reasons described earlier in
 this testimony. Please see Schedule EEW-1 for additional detail on these calculations.

6 Q. Which adjustments should the Commission now use for purposes of resolving this issue?

7 A. For purposes of resolving this issue, the Commission should adjust test year expenses by

8 Laclede's initial proposed adjustment of \$614,885.29 plus the noncontested portion of

9 Staff's additional disallowance, \$339,541.24, for a total of \$954,426.53.

#### 1 **B. Medical Inflation**

2 Q. What adjustment to Staff's level of normalized medical expense are you sponsoring?

A. I am sponsoring an adjustment to represent Laclede's medical inflation experience in
 Staff's normalized medical expense. Staff adjusted Laclede's expense level for the
 Company's reduction in contract employees.

6 Q. Why is this adjustment appropriate?

A. The purpose of Staff's adjustment was to update Laclede's calculation to a March 31,
2010 annualized level of expense. Staff took into account the fact that Laclede had fewer
contract employees and reduced the company's normalized medical expense accordingly.
However, Laclede experienced inflation in its medical expenses during the update period
that is not reflected in Staff's adjustment. Laclede's adjustment is appropriate in order to
present a more comprehensive snapshot of the components that drive Laclede's medical
expense, both downward and upward.

14 Q. What is the appropriate medical inflation rate to include in a March 2010 annualization?

A. Laclede uses an annual experienced medical inflation rate of 6% based on the Towers
Watson Health Care Cost Survey. The cost survey has represented a medical inflation
rate of 6% to 8% since 2005. Staff based normalized medical expense on the 12 months
ended March 31, 2010. The 6% annual inflation rate when applied to this period results
in a 3% increase to reflect normalized medical costs experienced between September 30,
2009 and March 31, 2010.

- 1 Q. What is the impact on Staff's adjustment to medical expense?
- 2 A. Please see the following calculation.

# 4 C. Health Care Reform Act

5 Q. What do Laclede's Health Care Reform Act adjustments represent?

6	A.	Laclede is seeking rate recovery for the known and measurable adjustments to its benefit
7		plans as a result of the recently passed health care reform legislation. Laclede is seeking
8		recovery of the costs to meet the following requirements: (a) to equate the co-pay of
9		mental health and chemical dependency ("MH/CD") providers with that of primary care
10		physicians ("PCP") in accordance with the Mental Health Parity Act; (b) to eliminate the
11		lifetime maximum payment available to a covered person under the medical plan; (c) to
12		cover preventive and wellness services at no cost to the individual (Laclede already
13		covered 100% for the care; this adjustment eliminates the co-pay); and (d) to cover
14		children of covered employees up to age 26.
15	Q.	What is the impact on Laclede's plans that needs to be reflected in rates?

16 A. Please see the schedule below.

- 2 Q. What is Laclede's source for this information?
- A. Sax Benefits Group, the Company's health care consultant, developed these costs based
   on a review of the impact of the changes mandated by the new health care legislation on
- 5 our participants.

### 6 D. Treasury Account Special

7 Q. What is the Treasury Account Special?

8 A. Treasury Account Special is an account used by the Company to book various expenses
9 of its officers and other employees.

10 Q. Should these expenses be considered in setting Laclede's rates?

A. Laclede excluded some of these expenses. However, many of the expenses are normal
 and customary business expenses incurred in the ordinary course of the Company's
 operations. Such expenses should be considered in setting the Company's rates.
 Examples of these expenses include CPA licensing fees and other professional dues,

- 15 travel expenses for Company business, and expenses related to membership in FRI.
- 16 Q. What is your objection to Staff's approach in this matter?
- A. In the past, Staff and the utility normally have agreed to this issue based on a reasonable
   assessment of these expenses. In this case, Staff has made an adjustment that simply
   removes a wide swath of these ordinary expenses. However, Staff witness Hanneken

indicated on page 79 of the Staff's May 10 Cost of Service Report that Staff's
disallowance is more of a placeholder than a final decision, and that Staff would review
and consider further information as it becomes available. Since the May 10 filing of
Staff's testimony, Laclede has discussed this issue with Staff and has responded to Staff
inquiries. Laclede hopes and expects that upon further review that this issue will be
resolved.

- 7 Q. Does this conclude your testimony?
- 8 A. Yes, it does.
