ORDER POSTPONING SECOND WORKSHOP

The Commission opened this working case at the request of the Office of Public Counsel to consider a rule regarding the reporting of residential customer disconnection data. The Commission scheduled a second workshop meeting to be held on January 27, 2022, to discuss such a rule.

On January 24, 2022, Public Counsel asked that the workshop meeting be postponed due to the COVID-19 pandemic. Public Counsel also requested leave to file, no later than January 28, 2022, a suggested new date for the second workshop. The Commission will grant Public Counsel's requests.

THE COMMISSION ORDERS THAT:

1. The second workshop meeting currently scheduled for January 27, 2022, is postponed indefinitely.
2. Public Counsel shall file a suggested date for rescheduling the workshop no later than January 28, 2022, or a status report indicating when it is able to do so.
3. This order shall be effective when issued.
