STAFF RECOMMENDATION FOR APPROVAL OF COMPLIANCE TARIFFS

COMES NOW the Staff of the Missouri Public Service Commission (“Staff”), by and through counsel, and hereby submits its *Staff Recommendation for Approval of Compliance Tariffs*. The compliance tariffs filed by Missouri-American Water Company (“MAWC”) on December 28, 2022, with the *Unanimous Stipulation and Agreement* agreed to by MAWC, Staff, and the Office of Public Counsel, comply with the Commission’s *Order Approving Stipulation and Agreement*, issued on January 4, 2023. Thus, Staff recommends approval of:

WHEREFORE, Staff recommends that the Commission issue an order approving MAWC’s compliance tariff sheets to implement the terms of the *Stipulation and Agreement* filed on January 4, 2023, and allow the revised tariffs to take effect January 16, 2023, or as soon thereafter as is reasonable; and grant such other and further relief as the Commission considers just in the circumstances.


