MOTION TO CONSOLIDATE

Comes now Missouri-American Water Company (MAWC or Company), and, as its Motion to Consolidate, states as follows to the Missouri Public Service Commission (Commission):

- 1. MAWC has filed with the Commission tariff sheets and direct testimony seeking a general rate increase for both its water and sewer operations. Two case numbers have resulted from these filings (WR-2022-0303 and SR-2022-0304).
- 2. The subject water and sewer operations are owned and operated by the same entity (MAWC) and have common offices, personnel and overheads.
- 3. Accordingly, there are common questions of law and fact in the above-referenced cases and the consolidation of Cases Nos. WR-2022-0303 and SR-2022-0304 would be administratively expedient in that it would simplify the filings to be made by MAWC and the other parties to these matters.
- 4. The Commission has stated, "Commission Rule 20 CSR 4240-2.110(3) allows for the consolidation of cases with related questions of law or fact.¹"

WHEREFORE, MAWC requests a Commission order consolidating Cases Nos. WR-2022-
