On February 16, 2023, the Commission issued its *Order Setting Procedural Schedule*. The order set a Discovery Conference for February 22, 2023. The order also requires that any party that has a discovery concern file a brief statement describing that concern at least three business days before each discovery conference. If no party identifies any discovery concerns the presiding officer may cancel that conference.

Staff filed a discovery dispute, but has since requested the discovery conference be canceled. Thus, the discovery conference is canceled.
