ORDER ESTABLISHING TEST YEAR

Effective Date: February 14, 2023

On December 21, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence or "the Company") filed a request for a general rate increase. Confluence proposed a test year of the twelve months ending June 30, 2022, and further proposed an updated/known and measurable period through December 31, 2022. Confluence did not propose a true-up.

On February 2, 2023, the Staff of the Commission (Staff) filed its response to Confluence's test year proposal. Staff's response represents that the Office of Public Counsel was informed of and did not oppose Staff's response. Staff proposed to change the updated/known and measurable period through January 31, 2023, rather than through December 31, 2022. Staff did not oppose the test year period nor the absence of a true-up.

On February 6, 2023, Confluence responded that it had no objection to extending the updated/known and measurable period through January 31, 2023. No other responses were received regarding Staff's proposed change.

The Commission finds the unopposed proposed test year to be reasonable and will establish it as the test year, without a true-up, and with Staff's unopposed change to extend the updated/known and measurable period through January 31, 2023.

THE COMMISSION ORDERS THAT:

1. The test year for Confluence's request to implement a general rate increase for its water and sewer service shall be the twelve month period ending June 30, 2022, with an updated/known and measurable period through January 31, 2023.
2. This order shall be effective upon issuance.
