ORDER DIRECTING RESPONSE TO TEST YEAR

Issue Date: February 3, 2023 Effective Date: February 3, 2023

On December 21, 2022, Confluence Rivers Utility Operating Company, Inc. (Confluence or "the Company") filed a request for a general rate increase. Confluence proposed a test year of the twelve months ending June 30, 2022, and further proposed an updated/known and measurable period through December 31, 2022. Confluence did not propose a true-up. The Commission set a time for responses to Confluence's test year proposal.

On February 2, 2023, the Staff of the Commission (Staff) filed its response. Staff's response represents that the Office of Public Counsel was informed of and did not oppose Staff's response. Staff's response notes that the parent company of Confluence recently acquired certain systems in South Carolina that may affect the level of allocated corporate costs to the ratepayers in Missouri. As such, Staff proposed to change the updated/known and measurable period through January 31, 2023, rather than through December 31, 2022. Staff did not oppose the test year nor the absence of a true-up.

THE COMMISSION ORDERS THAT:

- 1. No later than February 10, 2023, Confluence shall file a response to Staff's counter-proposal to extend the updated/known and measurable period through January 31, 2023, rather than through December 31, 2022.
- 2. No other party is required to respond, but if it so wishes such response must be filed no later than February 10, 2023.
 - 3. This order shall be effective when issued.
