ORDER APPROVING TARIFF

On October 18, 2016, Missouri-American Water Company filed a tariff to implement a residential low-income pilot program that was authorized in the Commission's report and order in Missouri-American's recently completed general rate case, File No. WR-2015-0301. That tariff carries an effective date of November 17.

The Commission directed its Staff to file a response to Missouri-American's tariff by November 4, and allowed other parties until that date to file a response if they wished to do so. Staff filed its recommendation on November 4, advising the Commission that the tariff complies with the Commission's prior order. No party filed a response.

The Commission finds that the submitted tariff should be approved.

1. The proposed tariff sheet submitted under Tariff No. YW-2017-0056 by Missouri-American Water Company is approved, effective on and after November 17, 2016. The specific tariff sheet approved is:
