- 3 record. Good morning. Today is Monday, July 14th,
- 4 2008. We are here for a prehearing conference in the
- 5 case Seth and Jeanette Langton versus Missouri
- 6 American Water Company, Case No. WC-2008-0350.
- 7 My name is Harold Stearley and I'm the
- 8 presiding officer on this matter. This case was
- 9 reassigned formerly from Judge Lane.
- 10 We will begin by taking oral entries of
- 11 appearance, beginning with the Staff of the Missouri
- 12 Public Service Commission.
- MR. KRUEGER: Keith R. Krueger for the
- 14 Staff of the Missouri Public Service Commission. My
- 15 address is P.O. Box 360, Jefferson City, Missouri
- 16 65102.
- 17 JUDGE STEARLEY: Okay. Missouri
- 18 American Water Company.
- 19 MR. JONES: This is Kenneth Jones with
- 20 Missouri American Water Company. I'm at 727 Craig
- 21 Road, C-r-a-i-g, St. Louis, Missouri 63141.
- JUDGE STEARLEY: Office of the Public
- 23 Counsel?
- 24 (NO RESPONSE.)
- 25 JUDGE STEARLEY: I see no one present

- 1 for the Office of the Public Counsel, and we'll let
- 2 the record reflect that. And Mr. Seth Langton, will
- 3 you please enter your appearance for us.
- 4 MR. LANGTON: Seth Langton, 733 Sherwood
- 5 Drive, St. Louis, Missouri 63199.
- JUDGE STEARLEY: Okay. Thank you,
- 7 Mr. Langton. And let me ask, are there any
- 8 preliminary matters that will need to be addressed at
- 9 this time?
- 10 MR. KRUEGER: Not from Staff.
- 11 MR. JONES: And not for Missouri
- 12 American, your Honor.
- 13 JUDGE STEARLEY: Okay. And let me ask
- 14 in terms of the current status of Mr. Langton's
- 15 service, has there been any interruption in his
- 16 service?
- 17 MR. LANGTON: No.
- MR. JONES: Not that I'm aware of.
- JUDGE STEARLEY: Okay. And are there
- 20 any current notices of disconnection circulating or
- 21 pending out there?
- MR. JONES: No, not the last time I
- 23 checked, your Honor.
- JUDGE STEARLEY: All right. Very well.
- 25 Well, in a moment here, we're going to end the record

1 portion of this, and I will leave the parties to have

- 2 an opportunity to discuss their case. They can
- 3 discuss their respective positions of their case, any
- 4 prospective settlement discussions, and I have
- 5 brought a calendar that I will share with Staff.
- 6 The order that was issued setting this
- 7 conference also directed that a procedural schedule
- 8 be filed a week -- actually, I believe July 24th was
- 9 the deadline set for that from Judge Lane.
- 10 If the parties reached some other type
- 11 of agreement or wished to handle this in some other
- 12 manner, they can simply file a status report at that
- 13 time.
- 14 MR. LANGTON: Can I ask a question?
- 15 JUDGE STEARLEY: Certainly, Mr. Langton.
- MR. LANGTON: On this order for this
- 17 prehearing conference, towards the bottom of the
- 18 order it says, "Commission ordered Staff to commence
- 19 an investigation of Mrs. Schwab's formal complaint.
- 20 The file report concerning..." et cetera, et cetera.
- I don't understand that. I don't
- 22 understand what Mrs. Schwab has to do with this, and
- 23 I don't know who Mrs. Schwab is.
- JUDGE STEARLEY: And that's a very good
- 25 point, Mr. Langton. Apparently Judge Lane, when he

- 1 issued this order, probably templated it off another
- 2 order, and that's an incorrect citation. It's the
- 3 wrong name there, so let's correct by interlineation.
- 4 That should read Seth and Jeanette Langton.
- 5 And I believe Staff has completed their
- 6 investigation and filed a report in this case. And
- 7 Mr. Langton, let me ask you, have you received a copy
- 8 of that report?
- 9 MR. LANGTON: I think I have.
- 10 JUDGE STEARLEY: Okay. And did you
- 11 receive --
- 12 MR. LANGTON: Well, I'm not sure if I
- 13 did or not. Tell me what's the date on -- on -- I do
- 14 have it. Report on -- yes, I do have it.
- JUDGE STEARLEY: Okay. Very good. And
- 16 did you also receive a copy of the company's answer?
- 17 MR. LANGTON: Yes, I did, yes.
- 18 JUDGE STEARLEY: Okay. Very good. And
- 19 I apologize for the typographical error there. I
- 20 don't have any idea who the Schwabs might be also. I
- 21 appreciate you pointing that out.
- 22 Are there any other -- I'll ask one more
- 23 time, are there any other matters I need to take up
- 24 at this time from the parties?
- MR. KRUEGER: Not from Staff, your
