2 JUDGE GRAHAM: It's July the 9th,
3 2021, and I'm showing that it is now 10:05 AM.
4 The Commission has set this time for a
5 procedural conference in the case captioned
6 as William B. Rilenge, Complainant, versus
7 Missouri American Water Company, Respondent.
8 That's file WC-2021-0251.

9 My name is Paul Graham and I'm the
10 Regulatory Law Judge in this matter. We'll
11 begin by having the attorneys and parties
12 make their entries of appearance.

13 For the record, is William B.
14 Rilenge here at this time?

15 Okay. I hear nothing in response to
16 that question.

17 Will the attorney for the Commission
18 Staff please enter her appearance?

19 MS. ASLIN: Casi Aslin for
20 Commission Staff. My address is 200 Madison
21 Street, Jefferson City, Missouri, 65102.

22 JUDGE GRAHAM: Thank you very much.
23 I don't believe we have anybody here from the
24 Office of Public Counsel.

25 Would the attorney for Missouri

1 American Water Company please make his
2 appearance?

3 MR. COOPER: Yes, Judge. Dean
4 Cooper from the law firm of Brydon,
5 Swearingen & England, PC, P.O. Box 456,
6 Jefferson City, Missouri, 65102, appearance
7 on behalf of Missouri American Water Company.

8 JUDGE GRAHAM: Okay. I will ask
9 again is William B. Rilenge here?

10 Okay. For the record an order was
11 issued in this case setting the procedural
12 conference. That order was issued on June
13 28, 2021. It was effective on that same
14 date. It set the matter for a procedural
15 conference for July the 9th, that's today,
16 2021, at 10:00 AM, via WebEx.

17 The order provided contact
