MAWC’S REPLY TO OPC RESPONSE

COMES NOW Missouri-American Water Company (“MAWC” or “Company”), and, as its *Response to OPC Request*, respectfully states as follows to the Missouri Public Service Commission (“Commission”):

1. In response to the Commission’s *Order Shortening Time to Respond*, the Commission directed that the Office of the Public Counsel (“OPC”) “shall file a statement, with specificity, as to the facts or issue and which page and line numbers of testimony are needed from WO-2018-0373 that were not in the record of the current case, WO-2019-0184.”

2. On May 22, 2019, OPC filed its *Response to Commission Order Directing Filing*. Therein, OPC identified two specific situations where facts are needed (Tr. Vol. 1, 52:16-18; and, finding at para. 20 of the *Report and Order*).

3. As to the two specific items identified, MAWC does not object to the use of those two references. However, as to the Transcript reference, MAWC asks that the additional material also include lines 13-15, on page 52 of the Transcript, which contain the following question and answer:

13 Q. Carryover means you're bringing forward from
14 year to year?
15 A. Correct.

This additional reference provides the context for Mr. Wilde's statement in that it shows the subject of the question and answer related to the net loss carryover (or forward), and not the net operating losses directly associated with the ISRS plant.

WHEREFORE, MAWC submits this *Reply to OPC Response* for the Commission's consideration.
